In 2008, the Saskatoon Community Foundation saw its second largest granting year ever, with over \$700,000 granted to 140 charities. Through this support, these groups are entrusted to deliver vibrant community programming in one or more of our seven areas of focus: Family and Community, Health, Education, Human Development, Arts and Culture, Environment and Research, Strategy and Capacity-Building. The diversity of groups that apply for and receive grants from the Saskatoon Community Foundation continues to grow. These organizations are key partners with the Foundation and embrace its mission of making Saskatoon the best community in which to live, always innovative in addressing the most pressing needs in our community.

Due to impacts of the worldwide economic downturn, 2008 was a year that revealed significant challenges for the Foundation. After thoughtful and considered deliberations late in 2008, the Board of Directors of the Saskatoon Community Foundation agreed that it will not issue grants from its endowment in 2009. Community foundations from all across Canada, and in fact around the world, are enduring similar challenges because they rely on investment income from their endowed funds in order to support their communities.

This was also a year of many changes for the Board of Directors. With regret and our deep appreciation for their service, we said farewell to board members Dale Linn, Jim Wasilenko, Wes Heinrichs and Penney Murphy. Dale, Wes and Jim served on the Board in various roles for eight years, and Wes remains a member of the Grants Committee. Penney’s contribution to the Marketing Committee was invaluable in the creation of the Mayor’s Gala. We also welcomed Ross Harwood and Paul Tiessen to our team, and we look forward to their contributions in 2009.

So many volunteers and supporters play a role in the success of the Saskatoon Community Foundation, from committee members to Youth Advisory Council volunteers, to all those who help to make our special events successful. On behalf of the Board of Directors and the Foundation staff, I’d like to express our gratitude to everyone who helps to make Saskatoon the best community in which to live, through their gifts of time, talents and financial support.

We live in a unique community, with a proud history, an energetic present, and a future full of promise. As the only community foundation in Saskatoon, we look forward to playing a defining role in supporting and sustaining Saskatoon as that promise reaches fruition, just as we look forward to reaching our goal of growing the endowment to reach an annual granting level of more than \$1 million dollars.

**YEAR IN REVIEW**

In 2008, the endowment declined to \$16,554,772 from \$17,446,690 at December 31, 2007, a decrease of 5.5%.

With the worst investment returns in decades, the Foundation experienced significant losses to its investment portfolio. It may be some consolation, however, that based on the information received to date, the Foundation’s investment performance was among the best in the community foundation movement across Canada. Many donors have indicated that the Foundation’s performance was significantly better than their personal returns.

With a turbulent year in the markets, the Foundation experienced investment returns of -10.73%, compared to 1.6% in 2007 and 10.89% in 2006. Total investment loss for the year was \$2,213,885 (2007 income: \$232,611).

**Annual donations exceeded \$2,000,000 for the second time in the Foundation’s history.**

The Foundation granted \$734,323 in 2008, making 257 grants to 142 charitable organizations. Canada Revenue Agency requires public foundations to disburse a minimum of 3.5% of the average endowment based on the previous 24 months. Saskatoon Community Foundation has granted 4.5% of the average endowment for the past four years.

Net operating expenditures, after grants and donations designated for administration, were \$299,005 or 1.6% of the endowment (2007-1.4%). The operation of the Foundation involves not only building endowments, but comprehensive activities related to strategic grant making and community leadership. These activities are not necessarily related to the donations received in any one year, and the endowment building methodology used by the Foundation creates normal gift delays, which may result in costs preceding the receipt of the gifts by several years. In the view of management, the ratio of total operating expenses to total assets should be used to evaluate the operational costs. Ratios may fall within a range depending on the size and stage of development of a community foundation. Management considers the ratio of 1.6% to be within an acceptable range compared with benchmarks established in the community foundation movement, and continues to monitor both the actual results and the benchmarks on an ongoing basis. Community leadership represents the work of the Foundation to provide technical assistance to other philanthropic organizations and projects, as well as fostering the growth of community philanthropy.

**The total number of funds managed by the Foundation grew from 168 to 178, an increase of 6%.**

Nine endowed funds were added, as well as one new managed fund for the Saskatoon SPCA. Managed funds are not part of the endowment, but are managed on behalf of charities. The funds remain available to the charity and benefit from being part of the larger investment pool managed by the Foundation.

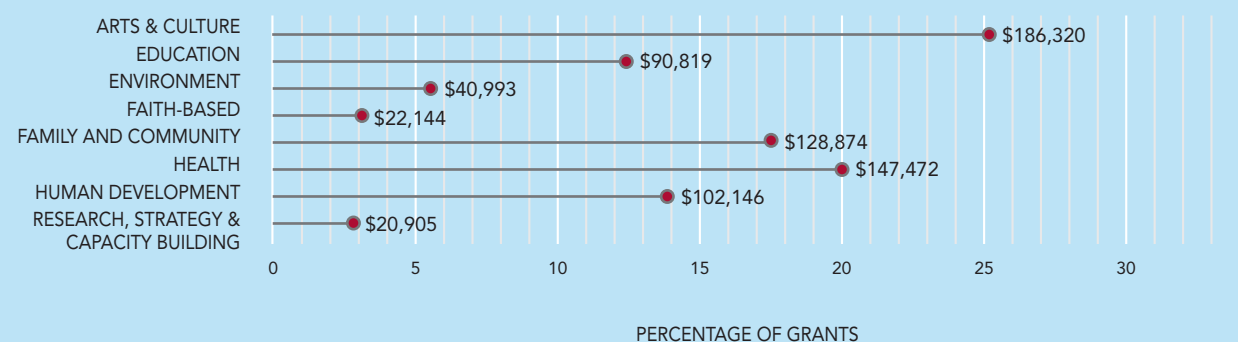

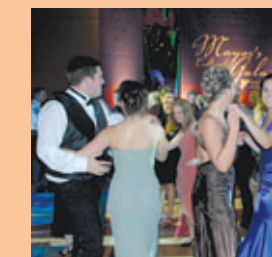

## ALLIES PROJECT



ALLIES (Assisting Local Leaders with Immigrant Employment Strategies) is an innovative program that brings together local organizations serving immigrants and local business leaders. The goal is to help new workers find meaningful employment in their new home communities.

A collaboration between the J.W. McConnell Family Foundation and the Maytree Foundation, ALLIES seeks to create a national movement of locally engaged communities who are providing successful employment solutions for skilled immigrants. The project will provide funding and support communities in their efforts to learn from, adapt, and implement successful approaches used by the Toronto Region Immigrant Employment Council (TRIEC) and others. Building on its success in larger cities, Saskatoon is one of two smaller cities in which the project is being tested. The Saskatoon Community Foundation is the convening organization for ALLIES Saskatoon.

The Saskatoon ALLIES Project Steering Committee includes representatives from the Saskatoon Community Foundation, the City of Saskatoon, Saskatoon Open Door Society, International Women of Saskatoon, Saskatoon Intercultural Association, The Chamber of Commerce, Saskatoon Regional Employment Development Authority, Can-Sask Career and Employment Services, Citizenship and Immigration Canada, the Government of Saskatchewan's Ministry of Advanced Education, Employment and Labour, as well as other concerned stakeholders.

The first phase of the project, a feasibility study to determine issues and action steps, took place in the fall of 2008. The study discovered that an information network for stakeholders would improve communications and opportunities for collaboration on immigrant employment initiatives. Phase 2 will take place in 2009 and further develop partnerships and information sharing among those who serve immigrants in the Saskatoon labour market.

**SWITCH (STUDENT WELLNESS INITIATIVE TOWARD COMMUNITY HEALTH)**

**CANADIAN RED CROSS – ABORIGINAL OUTREACH FOR INJURY PREVENTION**

The fastest growing segment of our population is Aboriginal people. Recognizing this, the Red Cross has created programs designed to engage aboriginal people, particularly youth, in order to build partnerships and increase knowledge that will help to prevent injury and respond to emergency situations. Most notable are programs to train both babysitters and trainers who can in turn, train more babysitters, increasing the community's capacity to care properly for its own. As well, in partnership with several community schools, first aid training is being provided for parent leaders who work with various community coordinators at the schools. The Red Cross continues its long and successful history of working to reduce suffering and improving our community's capacity to deal with emergencies.

## NASSER FAMILY FOUNDATION FUND



Karim (Kay) Nasser first spotted Dora walking across the campus grounds of the University of Beirut, in Lebanon. Kay was studying to become an engineer and Dora was studying to become a teacher. However, their paths didn't literally cross at university, although Kay claims that he "did better on his exams on the days that he saw her."

With encouragement from his mentor and head of the Department of Engineering, Kay answered an "engineers wanted" newspaper ad for Tapline (Trans Arabian Pipeline Company). The construction

project, an oil pipeline terminal, was to be built in Sidon. And directly across the street from Kay's new apartment was Dora's family home. Clearly, it was fate!

Yet the marriage was a long time in coming. Kay knew that further education was key to success and he was awarded a full scholarship to the University of Kansas to pursue his Masters in Engineering, with the full support and encouragement of his employer. Dora and Kay were married, finally, in Lebanon on April 11, 1955.

The idea of immigrating was not a new one for Kay. His grandfather had worked and lived in the USA for most of his working career, prospering and sending financial help back to the rest of the family. Growing up, Dora had imagined that she would live her life in Lebanon, teaching until marriage. Their first posting together was to Saudi Arabia, and then on to Bethlehem, Pennsylvania; a compromise which was closer to some of Dora's relatives. Dora became the Assistant Editor of the Alumni Magazine at the University there, a job that she calls "a Godsend." They had their first three daughters in quick succession: Selma, Mona and May. In order to truly succeed, they realized that further education was needed. Dora returned to her parent's home in Lebanon with their three daughters, for three years, while Kay worked, studied and eventually earned his PHD in Engineering at the University of Saskatchewan. They wrote each other weekly—a trunk-load of letters—and finally, Kay was able to bring his family to join him in Saskatoon.

After moving to Saskatoon, Dora (who, shortly after coming to Canada became a life-long CBC radio fan) continued her studies, first to graduate school and then achieving her Bachelor of Education, with distinction. She truly believes in life-long learning. During that busy time, two more children were added to the family: Roseann and John.

Kay supported the family through teaching, consulting and constructing in Saskatoon. In 1964, the Bank of Montreal lent them the dollars needed to construct their own apartment building. They have prospered ever since.

The Nasser's firmly believe that family comes first. They have looked after their family. Their gifting of education—U of S scholarships for university students in financial need—has become a priority. In addition, they are able to give back to their "greater" family, the community at large, through their family fund at the Saskatoon Community Foundation.

## A.H. BROWNE MEMORIAL SCHOLARSHIP IN HORTICULTURE FUND



A.H. BROWNE – "THE MAN WHO MADE SASKATOON BEAUTIFUL."  
1883-1957

Alfred Henry Browne was born in London, England. At the age of 14, he began his work as a gardener's apprentice at the Downton Abbey in Somersetshire, England. Through a five-year apprenticeship he advanced his horticultural skills, working with plants, trees, fruit and flowers. In 1906, he immigrated to Canada – first to Ontario, and eventually, to Saskatoon.

When "the Man of Trees" began his work in our beautiful city, there was nothing but native poplar and willow trees growing along the riverbank.

He was hired in 1909 as the first "city gardener" for the City of Saskatoon, a title that was changed over the years to "Superintendent of Parks and Cemeteries." When "the Man of Trees" began his work in our beautiful city, there was nothing but native poplar and willow trees growing along the riverbank. He planted up to 2000 maples and elms per year in his first years on the job, including those that now shade Saskatchewan Crescent and Spadina Crescent. The beautification of the riverbank began in the 1930's as a relief project. In his 44 years of beautifying our city, A.H. Browne and his co-workers planted over 30,000 trees.

In addition, Mr. Browne established the city greenhouse to produce the bedding plants for parks and boulevards. He oversaw the establishment of the city's own tree nursery (in the early years, they imported trees from a Winnipeg nursery). The "park picture" in Saskatoon, from 1909 to 1953, is the creation of A.H. Browne and his staff that he emphasized "[was] a first-rate staff just as interested in Saskatoon's horticultural beauty as I was."

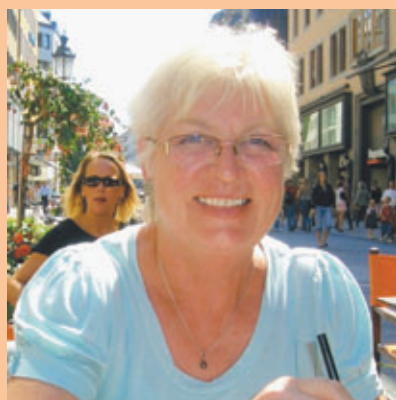
A.H. Browne was one of the founding members of the Saskatoon Horticultural Society and was awarded life membership in the Saskatchewan Horticultural Society Association.

Saskatoon has developed into the most beautiful city in the prairie provinces, and the residents of Saskatoon experience the legacy of A.H. Browne every day. His youngest of three daughters, Joan Browne, wanted to make sure that this legacy lives on even longer, through her gift of education.

Through her end-of-life planned gift, Joan has made the decision to establish the A.H. Browne Memorial Scholarship in Horticulture through the Saskatoon Community Foundation. This student award is intended for students enrolled in the third or fourth year of the B.S.A. program through the College of Agriculture, at the University of Saskatchewan. It is a fitting tribute to her father.

## BRIGITTE HOLL EDUCATION FOR ABORIGINAL STUDENTS FUND



Brigitte Holl was born in the province of Silesia, Germany, in 1941. After World War II, this part of Germany became a part of Poland. In the last months of the war her parents, Klaus & Elfriede, and their two daughters, fled from the Red Army and arrived in Bavaria, a southern province of Germany occupied by the American Forces. This is where they settled.

Brigitte married Nick Holl in 1969 in Munich. In 1978, Brigitte and Nick immigrated to Saskatoon. Nick, an engineer who specialized in hydrology, accepted employment with Key Lake Mining, which later became Cameco Corporation, where he enjoyed a long and outstanding career.

She was fascinated with stories about Aboriginal culture, spirituality and bravery, and came to identify with their long struggle for independence.

Nick and Brigitte separated in 1983, remaining friends until Nick was killed in a car accident in 2007. They were not blessed with children.

Brigitte started her career in Real Estate in Saskatoon in 1979, and continued this profession very successfully until her retirement in June of 2007. During this time, she served on the Saskatoon Real Estate Board (now SRAR) as a director and on many committees. She also served on the Heritage Advisory Committee for eight years, as well as on the Saskatoon Tax Revision Board.

From an early age, Brigitte read romanticized novels about North American Aboriginal people. She was fascinated with stories about Aboriginal culture, spirituality and bravery, and came to identify with their long struggle for independence.

Once in Canada, Brigitte was introduced to reality concerning the Aboriginal population. Carol was also raised in Manitoba. She has her dad’s red hair and even temper. “Red” Paterson was a well-known “star” hockey player. Carol’s mother, Betty, taught Carol to save, clip coupons, cook and create a happy, hospitable home. The devastating mining accident death of her 20-year-old brother David, taught Carol to value what is most important – people and what they mean to you.

Carol and Rick met at Minnedosa Lake. Right from the beginning, she was impressed with his honesty. They were married on July 2, 1977, at Inglis, Manitoba. Carol has since learned, “If Rick decides it is going to be successful, it will be successful.” But the early years were lean and it was not unusual for Carol to ride along, seated on a lawn chair, to keep driver Rick awake during late-night propane runs.

Carol and Rick waited for six long years before adopting their son, Michael David Duval, in August of 1987. Theirs is an open adoption, and Michael has grown up knowing that he is special and loved and that “we got to pick you.” Both Carol and Rick state, “All babies, especially adopted ones, should come with instruction books!”

Michael is still finding his way career-wise, but he knows that he wants to be “understanding and compassionate” like his Mom, and “honest, hard working and able to succeed without compromising,” like his Dad.

The Duval Family Foundation Fund is a donor-advised fund at SCF. The Duval family will be consulted annually about their granting preferences. When Carol and Rick can no longer be consulted, their son Michael will continue the Duval philanthropy, helping our community forever.

## THE BABY THOMAS BOECHLER MEMORIAL FUND

For his family, the brief time Thomas Boechler spent with them did not diminish the depth of their love for him. According to his grandfather, Dan McDonald, “It is true what people say – life is always a mixture of joy and pain. It is also true that while the pain never goes away, its deepest depths are slowly filled-in by joy, and life continues.”

In late August, 2005, Thomas’ mother Melissa was visiting her parents with her daughter, Nicole. Melissa was about five months into a very high risk pregnancy and had been warned to go to the hospital at the first sign of any bleeding. This information saved her life. While enjoying a peaceful family visit on August 20, Melissa noticed some bleeding and an ambulance was immediately called. Once she was at Royal University Hospital, despite excellent medical care, the bleeding would not stop. Later that day, the family called for Eric, her husband to come home from Alberta.

Despite the family’s hope that all could be well, by August 21 the only option to save Melissa was to have an emergency Caesarean section. Baby Thomas then began his life. Sadly, Thomas was too small and premature to survive and died shortly after birth. Melissa, Eric and Nicole, and all the family, were devastated by Thomas’ very short life.

Meanwhile, Melissa was still fighting to save her own life. She had lost over ten units of blood and was still bleeding. The next step might have been to remove her uterus, and with it any chance of more children. Fortunately, Melissa received excellent care from Dr. Annette Epp. Dr. Epp proposed using nuclear medicine to cauterize the bleeding – a technique never before used in Saskatoon. Dr. Epp’s brilliant and innovative solution saved Melissa’s life; Dr. Epp is forever in the family’s thoughts and prayers.

Since then, Melissa has had another baby, Ian Douglas Boechler, thanks to help from Dr. Epp and all the staff at RUH. Even now, as the family rejoices in its newest member, all of them will always love, miss and remember Thomas. They established the Baby Thomas Boechler Memorial Fund for Royal University Hospital to honour his memory, give thanks for the excellent care they received, and to help other families in their times of direst need.

Bob and Laura Lacoursiere were both born in Saskatchewan and lived in Saskatoon since the late 1960s. They were married in 1974. Bob had three children from his first marriage. His oldest son passed away in 1995. His daughter, son and grandchildren live in Saskatoon.

Robert A. (Bob) Lacoursiere, son of Elmer Lacoursiere and Marie Jeanne (Blanchette) Lacoursiere, was born in North Battleford and raised in the Vawn/Edam area. Bob attended the University of Saskatchewan for a year before working as an accountant in several North Battleford area companies. He began articling for his Chartered Accountant (CA) designation in Saskatoon and received that designation in 1974. He began his own public accounting firm, later joining partnerships with other CAs. He was the Managing Partner with Ernst & Young Chartered Accountants in Saskatoon until his retirement from that partnership in 1991. He established a management consulting practice and received the Certified Management Consultant and Registered Financial Planner designations. In 1995, he joined a Saskatoon financial planning firm. At the time of his death, he was Branch Manager for an Assante Wealth Management office in Saskatoon.

Bob brought his energy, talents, and particularly his leadership to many organizations through the years, from amateur baseball and fastball, to the many business organizations he belonged to and lead, to his dedication to his community and the many hours he volunteered. He volunteered in baseball at the community (then North Battleford), provincial, national and international levels. He was President of the Saskatchewan Baseball Association, Western Canada Baseball Association and the Canadian Federation of Amateur Baseball. He coached a number of senior men's softball teams in Saskatoon, including the Saskatoon Merchants (the 1969 Canadian Champions) and the Saskatoon Jacks. Bob was inducted as an individual or as part of a team in the Saskatchewan Sports Hall of Fame, the Saskatoon Sports Hall of Fame and the Saskatchewan Baseball Hall of Fame. He was a life-long Toronto Maple Leafs fan. He enjoyed fishing, golfing (especially at Waskesiu Lake and Elk Ridge) and riding his Yamaha motorcycle. He volunteered and shared his leadership abilities with the YMCA, United Way, Saskatoon Board of Trade/Chamber of Commerce, Saskatchewan Place, SIAST, Waskesiu Cabin Owners' Association, Saskatchewan Rate Review Panel and other organizations. He was an observer of civic politics and was a candidate for Mayor of Saskatoon in two elections.

Bob was diagnosed with Non-Hodgkin's Lymphoma in mid-September, 2007, and died November 13, 2007. In the months following Bob's death, many people, friends and clients commented on the special things Bob had done for them – his impact was larger than his family knew.

Laura M. Lacoursiere, daughter of Robert (Bob) and Helen (Dickson) McKenzie, was born in Maidstone, Saskatchewan and raised in Glamis and Cut Knife. She graduated from the University of Saskatchewan with a Bachelor of Commerce. She received the Certified Management Accountant (CMA) designation in 1983 and an FCMA in 2001. Laura worked at the Kelsey Institute for Applied Arts and Sciences for over nine years, then at the Saskatchewan Legal Aid Commission for more than 26 years until her retirement in 2007. Laura volunteered with the Society of Management Accountants of Saskatchewan and served as Provincial President in 1998-1999. She served on several provincial and national CMA Canada committees. She has also volunteered with several other Saskatoon organizations.

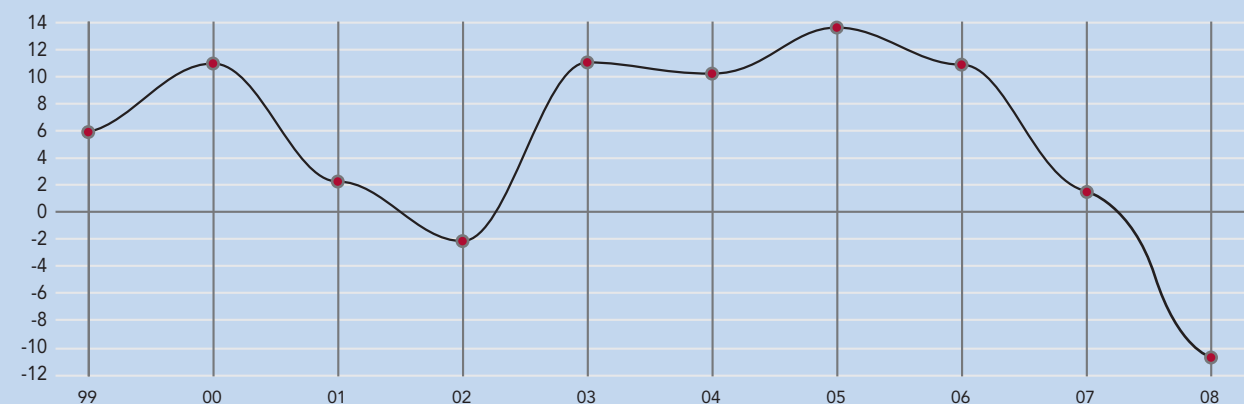
**Our investment philosophy reflects the following objectives:**

## HOW TO GIVE

When you decide to establish an endowment fund with the Saskatoon Community Foundation, you are making a lasting commitment to the community. You can make gifts of cash, a designation in your will, a life insurance policy, real estate, or a gift of appreciated publicly traded securities. These gifts to the Foundation are invested in perpetuity with the income granted to charitable organizations. This means your original gift will make an impact in the community today, tomorrow, and forever.

### TYPES OF FUNDS

**Unrestricted Funds** provide the Foundation with the most flexibility in responding to grant applications. This type of fund is not tied to any specific agency or field of interest, which allows the Foundation to address pressing, changing needs of the community.

**The Saskatoon Fund**, home to our memorial, tribute and Century Club donations, is one of the many funds that make up our Unrestricted Fund.

Memorial and tribute gifts allow friends and family to donate in memory, or in honour, of a loved one. Century Club is the club for "everyday philanthropists." Launched by Ross Pinder in 1982 to recognize Saskatoon's 100th birthday, Century Club members commit to donate at least \$100 a year.

**Field of Interest Funds** are established by donors who wish to support a specific charitable field of interest, such as arts, education, health, family and community, or the environment. Based on the donor's field of interest, the Foundation selects appropriate projects to support.

### Community Builders

Community Builders are donors who make deferred gifts—a life insurance policy, a charitable trust, or a bequest by will. Although the gift is deferred, tax benefits can be immediate.

### Flow-Through Funds

Flow-through funds are not endowed. Donors may flow funds through the Foundation to the cause of their choice

**Donor Designated Funds** are established by donors to support one or more specific charitable organizations in perpetuity.

**Donor Advised Funds** enable donors to be actively involved each year in recommending recipient charities.

**Student Awards** are established in the name of a donor, or in honour of someone else, to help individuals receive education or training they might not otherwise be able to access.

The Saskatoon Community Foundation is a charity itself with ongoing expenses. Contributors to the Administrative Endowment recognize the importance of building the Foundations' capacity to lead and serve the community.

**Agency Endowments** are funds established by charities to generate annual income for their use.

**Managed Funds** are also established by charities, but are not endowed. The funds can be withdrawn at any time, but benefit from being part of the larger pool of investments.
